
Please join us on Monday February 27, when residents are invited to celebrate the rich history of Indian Wells at the City's 50th Anniversary celebration. This will be the event of the year for the City, and we look forward to sharing it with residents.

For those who may be new to Indian Wells' colorful history, it all started with early inhabitants who unearthed the area's namesake well. Over the centuries, Indians, explorers, pioneers, and prospectors began to call this part of the Coachella Valley home, as the location ultimately became a stagecoach stop and then a key railroad destination. The reason? A natural source of water which continued to be treasured by all who came.

Fast forward to the 1950s, and to a landscape filled with pools, movie stars and amazing golf — and Indian Wells could be found playing host to names like Desi Arnaz, Frankie Avalon, Ray Bolger, Kirk Douglas, James Garner and Bob Hope. Arnold Palmer himself won the first local golf tournament here in town, and President Eisenhower visited regularly, ultimately becoming an Indian Wells homeowner.

To ensure that Indian Wells would be a community characterized by this distinctly fine residential/ country club living and resort hotels, in 1957, E.M. "Pete" Peterson, who became the city's first mayor, established the first property owners association. On July 14, 1967, Indian Wells officially became California's 400th city (and Riverside County's 16th city).

Today, our long-time City residents and our newcomers live in a community of beauty, tranquility, beautiful weather and an ideal location where friendly, resort-style living is within easy reach of major metropolitan areas.



A few spots remain for the popular Indian Wells Pro-Am Invitational, to be held February 3 and 4 at the Indian Wells Golf Resort. Festivities kick off on Friday evening with a 6-9 p.m. event reception and mixer, along with a mobile shop for amateurs. Competition then begins with an 11 a.m. shotgun start on Saturday, February 4.

Teams for this third annual event will consist of one professional and four amateurs or members, Professionals play their own ball in a standard stroke play format. Amateur's play a 2 best ball net shamble format. Teams can use their Pro's score

on any hole but are NOT required to do so. The pros will play for their share of the \$10,000 cash purse, eligibility for a \$3,500 skins purse and the coveted title of Indian Wells 2016 Pro-Am Champion. Winning amateur teams will receive awards and prizes including plaques for team members and stay-and-play golf packages to some of the top resorts in the nation. The winning pro will receive the Champion's Trophy and his/her name added to the perpetual Invitational Cup.

The entry fee of \$1,600 per team includes: tournament play with on-course competition, the February 3 Pro-Am reception

and mixer, a gift card for the Titleist-FootJoy Mobile Shop (amateurs only), a Tournament Tee gift (amateurs only), awards reception complete with hosted food and beverage, and a tournament highlight video. The City of Indian Wells has also created an online entry portal so that this year's teams can sign up and pay their entry fee online. # **Cold Weather Safety Tips for This Winter**

Here are a few tips to use in order to protect yourself, others and your home when outside temperatures drop. Special thanks to the Riverside County Fire Department for sharing this guidance with our Indian Wells residents.



#### Remember the three feet rule.

If you are using a space heater, place it on a level hard surface and keep anything flammable at least three feet away (such as paper, clothing, bedding, and rugs.)



#### Supervision is required.

Remember to turn portable heaters off when leaving the room or going to bed.



## Kitchen appliances are for cooking only.

Never use a stove or oven to heat your home.



# Prevent catching yourself or items on fire!

When using a fireplace, make sure to use a glass or metal fire screen large enough to catch sparks and rolling logs. Ashes should be cool before putting them in a metal container. Keep the container a safe distance from your home.



#### Layer up!

Wear layers of lightweight clothing to stay warm. Gloves and a hat will help prevent losing your body heat.



#### Use generators outside.

Never operate a generator inside the home, including in the basement or garage. Don't hook up a generator to the home's wiring. The safest thing to do is to connect the equipment you want to power directly to the outlets on the generator.



## Don't forget about your furry family.

Bring pets indoors. If they can't come inside, make sure they have enough shelter to keep them warm.

# Be a Champions Volunteer at the 2017 BNP Paribas Open.




## Is Set for February 25, 2017

# Be Prepared. Earthquake Advice for California Residents

In a recent City newsletter, tips were shared for creating household supply and survival kits to be used during emergencies. Our next series of tips relates specifically to earthquake emergencies what to do and where to go. Here are some best practices for these situations:

DROP, COVER AND HOLD ON.

**Emergency** authorities agree that this is the best procedure for protection indoors during an earthquake. Drop to the ground; take cover under heavy furniture such as a desk, table or bench; and hold on to your position until the shaking stops. Most earthquake fatalities result from collapsing walls, flying glass and falling objects. Do not attempt to leave the building because falling debris may strike you. Furthermore, the American Red Cross and federal government agencies have not advocated the use of a doorway for earthquake protection for more than two decades. Many doorways are not built into the structural integrity of a building.

IF YOU ARE IN BED and cannot drop and take cover under heavy

furniture, hold on and stay there, protecting your head with a pillow. IF YOU ARE IN A HIGH-RISE BUILDING, expect the fire alarms and sprinklers to go off during a quake. Familiarize yourself with the nearest emergency exits. IF YOU ARE OUT-OF-DOORS, avoid standing directly outside of buildings, at exits and next to exterior walls. Find a clear spot, drop to the ground, and stay there until the shaking stops. Many fatalities occur when people run outside of buildings and are killed by falling debris from collapsing walls. **IF YOU** ARE IN A MOVING VEHICLE, move immediately to a clear area away from buildings, trees, bridges, overpasses or utility wires. Stop and stay in the vehicle until shaking completely subsides, then proceed with caution avoiding bridges or ramps that may have sustained damage.

✓ Residential earthquake planning is key. The most important action you can take surrounding a major earthquake is to develop an action plan and prepare by obtaining all the supplies you will need to be self-

suffcient for at least seven days after a major quake strikes. If you live alone, establish an emergency plan with relatives, friends, coworkers or a community-based organization. Families should plan to share responsibility and work as a team. Knowing what to do when disaster strikes is your best protection.

✓ Know your environment. Determine the safe spots in each room, such as under sturdy tables, desks or against inside walls. Also, know the danger spots including windows, mirrors, hanging objects, fireplaces and tall furniture. Usually, an uncrowded hallway is one of the safest places. Kitchens and garages tend to be the most dangerous.

✓ Fasten large shelves and furniture securely to walls.

✓ Teach all family members how to shut off gas, water and electricity in case the lines are damaged.

✓ Conduct practice drills by physically placing yourself and your family members in safe locations.

# **Update on Landscaping Projects and Approval Processes**

The City of Indian Wells has programs in place to make it easier for residents to adjust their landscaping to a more drought-tolerant palette. Please remember that any changes such as lawn/turf conversion or other landscaping adjustments require that residents get proper City permits, and that landscape projects within the City are first subject to review by the City's Planning Department and applicable homeowners

association (HOA). It is expected that the associated plans presented for review shall comply with the basic zoning and design parameters set forth in the Municipal Zoning Code and such design guidelines established by the City, and shall show size, location, spacing and species (common and Latin name) of proposed planting, including a complete plant palette. All residential structures must be landscaped to provide a mature

appearance so as to blend with existing neighborhoods and enhance the overall appearance of the residential areas. Use of rocks or bare earth in lieu of ground cover plantings may not exceed 20% of the total front yard landscaped area excluding driveways, decks, pools, or walkways. On a related note, individual HOAs may have more restrictive landscaping requirements, so please be sure to contact your

- ✓ Always know the alternative exits for your home and workplace in emergency situations.
- ✓ Have disaster supplies readily available, and learn first aid and cardiopulmonary resuscitation (CPR) from your local Red Cross or American Heart Association chapter or other community organization.
- ✓ Decide where your family will reunite if separated. Make sure that young children learn to recite or write their names, parents' or guardian's names, and their phone number and address.
- ✓ Create a neighborhood plan. Identify neighbors who have special needs or will require assistance.
- ✓ Develop an emergency communications plan. Keep a list of emergency phone numbers and instruct all family members, especially children, on how and when to call 9-1-1 and other emergency services, as well as which radio station to tune into for emergency information. Choose an out-of-state friend or relative whom family members can call after the quake to report whereabouts and condition.

✓ Should the accidental or intentional release of chemical, biological, or radiological contaminants occur, local authorities will provide information on radio and television on how to protect you and your family. Consequently, it is important to keep a TV or radio on, even in the workplace. #### **Home Planning Tips:**

- ✓ Check chimneys, roofs and wall foundations for stability. Make sure your home is bolted to its foundation. Call a licensed contractor if you are not certain or have questions.
- ✓ Store breakable, hazardous and flammable items in low, closed cabinets with latches.
- ✓ Hang heavy items away from areas where people sleep or sit and brace overhead light fixtures.
- ✓ Secure your water heater by strapping it to wall

- studs and bolting it to the floor.
- ✓ Get expert advice if there are signs of structural defects and repair deep cracks in the foundation or ceilings.
- ✓ Maintain emergency food, water and other supplies, including medicines, protective clothing, battery-operated radio or television, and first aid kit.

#### **Survival Kit for Automobiles:**

- ✓Drinking water (preferably in Mylar packets to conserve space) as well as non-perishable food.
- ✓ Change of clothing and blankets, pre-moistened towelettes, and toilet tissue.
- ✓ First aid kit with manual and prescription medicines.
- ✓ ABC-type fire extinguisher and Emergency Signal Device such as a light stick or battery-type flasher.
- ✓ Small mirror and whistle to signal for help.
- ✓ Flashlight with spare batteries and bulbs.
- ✓ Polyethylene rope for towing, short rubber hose for siphoning and tools including spare tire, jack, lug wrench, pliers, and screwdriver.

respective HOA for written approval prior to submitting your mandatory application to the City's Planning Department.

Coachella Valley Water District programs are in place to assist Indian Wells homeowners interested in reducing their water usage by converting lawns to drought-tolerant landscaping, by installing smart irrigation controllers, by replacing inefficient spray nozzles and by installing water-efficient toilets. Reducing outdoor usage is the best way to save water and, as an example, the CVWD turf-replacement rebates offer \$1 per square foot up to a maximum of 2,000 square feet per project, with a maximum specfied per home. 




#### SCE COSTS KEEP INCREASING

SCE customers continue to see increases in their bills annually in excess of 10% and the trend is projected to continue indefinitely. Methods used by SCE to increase the costs customers pay include:

- Altering the amount of allowable kilowatts per tier each month, forcing the customer to purchase more energy in the more expensive tiers 2-4.
- Reducing the number of tiers (recently from 5 tiers to 4 tiers).
- Increasing the cost per kW in each tier.
- Introducing minimum monthly admin charges.

SCE has also received approval to switch its residential customers to a Time of Use (TOU) rate system beginning in 2017. In TOU, customers are charged by the time of day they use energy, rather than by how much they use. The cost charged in peak daytime hours is much higher than in the evening, overnight and early morning. There are only 2 rates: High Peak and Low Demand.

TOU rate plans are excellent for customers with solar panels. During the day, when the panels are producing all the power needed, there are no SCE charges incurred. Any power sent out to the grid is credited at the high rate. When solar customers pull power from SCE during non-producing hours, they pull from their stored credits first, then incur charges at the lower rate.
