Wade McKinney

Appointed Indian Wells City Manager



The City of Indian Wells is delighted to announce the appointment of new City Manager Wade G. McKinney who will officially begin his post as the City's lead administrator on July 1, 2013. Indian Wells City Council identified McKinney as its top candidate for the position after a lengthy recruitment process conducted by Sacramento-based executive search firm Peckham & McKenney.

McKinney brings an impressive 34-year public service background to his new role; most recently serving as the City Manager for Atascadero, California for nearly 16 years. While at the City of Atascadero, he supervised a staff of more than 115 full-time employees and played an integral role in strategic planning, sound fiscal management resulting in General Fund reserves, communications, and engaging community residents in identifying and implementing priorities for General and Master Plan updates. Prior to Atascadero, McKinney served as City Manager for Shafter, California in Kern County from 1986 to 1997.

McKinney is the President of the California City Management Foundation whose mission is to promote and encourage excellence in city management. He has also led the Strong Cities — Strong State program and was recognized by his colleagues in 2011 for his "Outstanding Service to the Profession." In 2009, he was awarded the "Citizen of the Year" by the Atascadero Chamber of Commerce.

I am very excited to join the team at the City of Indian Wells. I believe in customer service, team building and strategic planning. I am committed to the 'platinum rule' which I define as "Do unto others as they would have you do unto them."

A California native, McKinney has been married to his wife Cheryl for 33 years and has two married sons and two "wonderful" granddaughters. He possesses a bachelor of science-urban planning degree from California State Polytechnic University, Pomona.

Blood Drive Challenge Aims to Increase Local Blood Donations

Of course, the real winners of the challenge will be area hospitals and patients in need of blood products and services.



The City of Indian Wells will hold its blood drive on Wednesday. July 17 from 8 a.m. to 2 p.m. in the Celebrity Ballroom of the IW Club at the Indian Wells Golf Resort. What's more, the Blood Drive is offering a free ticket to Knott's Soak City Water Park in Palm Springs to each blood donor.

their loved ones. Maintain your regular eating schedule, and increase your fluid intake (water is best) in the 48 hours prior to donating.

Southern California Gas Company (SoCalGas) is about to make it easier for you to control and manage your energy costs! SoCalGas field



technicians will be in Indian Wells in June and July to upgrade natural gas meters with an advanced meter communications device.

Advanced meter installations will typically occur Monday through Friday from 7 a.m. to 5 p.m., taking approximately 15 minutes to complete. In most

cases, you will not need to be present and should not have an interruption to your gas service. Until the communications network is fully operational, SoCalGas employees will still need access for a few more months to manually read your meter.

Please provide safe access to the natural gas meter by keeping the area around the meter clear of any obstructions, plants or shrubs. If you have a locked gate or a dog that prevents access, please call the Advanced Meter Customer Information Center at 1 (877) 268-6211 (weekdays 7 a.m. to 8 p.m. or Saturdays 8 a.m. to 5 p.m.) to make access arrangements.

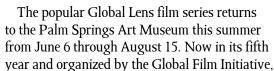

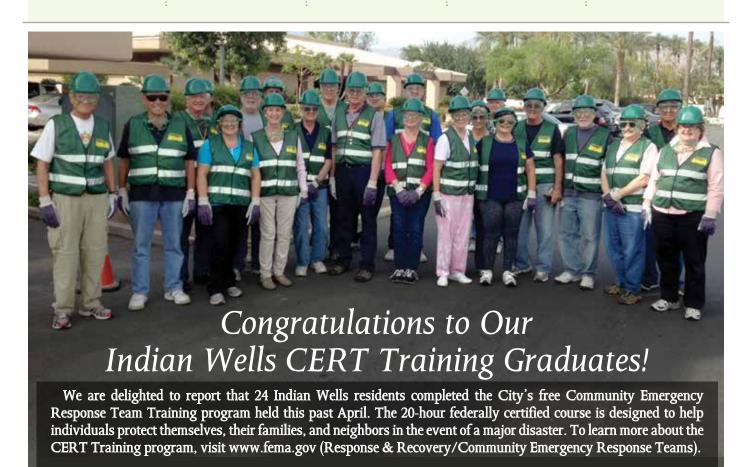

Fire Department Safety: Pool Safety

Too often, firefighters hear people say, "It was just a few seconds." Unfortunately, just a few seconds is all it takes

for a child to drown. Nationally, drowning is a leading cause of death for children under five.

Most of these children drown in their own backyard swimming pool, but others drown in buckets, bathtubs, toilets, dog water bowls, canals and ponds. Small children are top-heavy, and they don't have

 Never leave small children unsupervised – even for a few seconds.

 If a child is missing, check the pool first. Seconds count in preventing death or disability. Go to the edge of the pool and scan the entire pool, bottom and surface, as well as the pool area.

• Do not use flotation devices as a substitute for supervision.

 Do not consider young children to be drown—proof because they have had swimming lessons. Children must be watched closely while swimming.

- Use an approved barrier to separate the pool from the house.
- Never allow children to be alone near a pool or any water source.
- Have life-saving devices near the pool, such as a pole/hook, or flotation device.
- Keep children away from pool filters, as the suction force may injure them or prevent them from surfacing.
- Keep large objects such as tables, chairs, toys and ladders away from pool fences.
- Post the 9-1-1 number on the phone.

the upper body strength to lift themselves out of one of these dangerous situations. Even if the child survives the incident, he or she is often left with permanent brain damage.

Drowning and near drowning can be prevented, and you can help! Anyone involved with the supervision of children needs to be aware of the dangers associated with any body of water. Below are some useful tips to prevent these needless tragedies.

- Learn to swim.
- Always have a "designated child watcher."
- Do not allow children to play around the pool and store all toys outside the pool area.
- If you leave the pool area, take the children with you.
- Never swim alone, or while under the influence of alcohol or medications.
- Never swim when thunder or lightning is present.
- Check the pool area regularly for glass bottles, toys or other potential accident hazards.
- Keep CD players, radios and other electrical devices away from pools or nearby wet surfaces.
- Anyone watching children should learn CPR and be able to rescue a child if needed. Stay within arm's length of your child.
- For above ground pools, steps and ladders to the pool should be secured and locked or removed when the pool is not in use.
- Never dive into unfamiliar or shallow bodies of water.
- Don't swim if you're tired or have just finished eating.



Time to Trim Your Palms

To comply with city ordinance provisions and also ensure that our neighborhoods remain pest-free and pristine, be sure to include palm tree trimming on your home maintenance schedule this summer.

Please note that date palms should have been trimmed by June 30. Washingtonians, fan palms, and all other palm trees must be trimmed by July 30. Tip: Have your trees trimmed close to the deadlines, after final bloom is assured, to avoid the expense of repeat trimming.

Stay Cool, Stay Healthy!

Once again, the Community Action Partnership of Riverside County is coordinating the operation of drop-in Cool Centers this summer to aid vulnerable individuals, seniors, the disabled, and others in need of temporary relief from the heat. Cool Centers will open to the public when the Riverside County Department of Public Health issues a "Heat Warning."

When temperatures soar, follow these common sense safety tips to protect yourself from sunstroke and other heat-related illnesses:

- Drink plenty of water, and avoid caffeine and alcohol.
- * Wear a wide-brimmed hat or use an umbrella for shade.
- Wear lightweight, light-colored, loose clothing.
- **☀** Slow down − rest in the shade or a cool place whenever possible.
- * Take a cool shower or bath.
- Never leave a child, elderly or disabled person, or animal alone in a vehicle.
- * Check on friends and neighbors who are elderly or have medical conditions, or are at a higher risk for problems when it's hot.
- If you do not have an air conditioner or your unit is not working, use a fan, make sure your windows are open, or visit an air-conditioned mall, library, senior center or Cool Center.
