Branding and Beautification Strategy Ensures Savings in Water and Costs

Sustainability. It's a word that's tossed around a lot these days, but in Indian Wells we're committed to turning this word into action. Indian Wells has long created and employed programs to help maintain the delicate balance between development and nature. However, in 2009, this plan was formalized when City officials and staff developed Getting Greener: Indian Wells' Path to Sustainability, a comprehensive roadmap designed to conserve environmental resources while realizing economic and social benefits. Yet what's unique about Indian Wells is that city leadership has adopted a smart, multifaceted approach by incorporating branding elements that beautify our community while simultaneously reducing


Take, for instance, the Highway 111 Phase 2 enhancement project completed earlier this fall. In addition to providing traffic calming measures and alleviating road noise, crews also installed a non-potable water irrigation line and state-of-the-art drip system to transport reclaimed water to lush and efficient plantings in the medians. The City expects non-potable water irrigation to save \$40,000 annually in the coming years.

energy usage, water consumption and operating costs.

However, the City's dedication to smart design, protecting our natural habitat and saving money isn't stopping there.

Now, the Public Works Department is undertaking a carefully planned reconfiguration of landscaping in the Osage Trail median and Mountain View Villas. To keep the 'Indian Wells brand,' or image, consistent, like the Highway 111 medians, the new layout will also feature a 'Mediterranean' color palette consisting of palm trees, perennials and annuals that require minimal watering and maintenance. At Osage & Mt. View Villas, the City expects to save an additional \$21,000 annually in reduced water cost and reduce general fund expenses, and eliminate the need for hand mowing of turf that contributes to noise and air pollution.

Look for more exciting and strategic changes in our community as City Hall continues to prudently manage Indian Wells' path to sustainability.


the United States, Bermuda, Canada, China, Greece, India, Russia, United Arab Emirates and the United Kingdom.

Help Indian Wells Get GREENER!

Take Advantage of City's Many Recycling Programs

According to the Environmental Protection Agency (EPA), the recycling rate in the United States has increased from less than 10 percent of municipal solid waste generated in 1980 to 34 percent in 2010. What's more, waste disposal in landfills has decreased from 89 percent in 1980 to approximately 54 percent in 2010. Yet there is still a long way to go to ensure that materials that can be recycled or reused don't end up in our landfills.

The City of Indian Wells, in partnership with Burrtec Waste and Recycling Services, offers Indian Wells residents much more than weekly trash and recycling collection. Below please find an overview of our community's diverse year-round and seasonal recycling initiatives in which all residents are encouraged to participate:

Annual Citrus Collection

January 1 through April 30, 2012

Residents may drop off freshly picked, unwanted citrus fruit at the collection site



citrus fruit at the collection site just north of City Hall near the fire station. Your generous donation will help to feed the hungry throughout the Coachella Valley. No tangerines, please.

Bulky Item Pick-Up

Refrigerators, bed frames and patio furniture: These are only a sampling of oversized items that Indian Wells residents can dispose of via a free



"bulky item" collection service (limit of four items for free per pick-up; additional items will be collected at \$10 each).

Bulky items must be placed near the regular trash containers

by 7:00 a.m. on the day a bulky item pick-up has been scheduled. To arrange a pick-up, call Burrtec customer service at (760) 340-2113.

Christmas Tree Recycling



From December 26 through the second week of January, Burrtec will collect Christmas trees on residents' regular trash collection day. Trees must be cut into four-foot lengths or smaller,

bundled, and placed next to the trash containers. Flocked trees must also be cut into four-foot lengths and placed next to the trash containers. Unfortunately, flocked trees cannot be recycled and are destined for the landfill.

Document Shredding Events

Saturday January 28, 2012 and Saturday, April 28, 2012



Minimizing opportunities for identity theft and promoting paper recycling are two reasons why the City sponsors two no-limit Document Shredding Events every year. Events are held at Burrtec's Palm Desert office located at 41575 Eclectic Street from 7 a.m. until 11 a.m. Proof of

Indian Wells residency is required (no commercial businesses, please). Paper clips and staples are acceptable, but not three-ring binders.

Sharps Program/Household Hazardous Waste/ Electronic Waste

Placing medical waste, particularly needles and lancets, in your trash container can be dangerous to those collecting the material. To safely dispose of needles and other medical "sharps," please place the used instruments in a puncture-resistant container with a secure cap



Mark the container "sharps" or visit City Hall for free "BioHazard" stickers for your container.

Once the container is full, please call Burrtec at (760) 340-2113 to collect the material along with any other household hazardous waste you have at no charge. Household hazardous waste

materials include paint, motor oil, chemicals, pesticides, batteries, and fluorescent lamps. Electronic waste includes TVs, computers, phones, monitors, printers, small appliances, and basically any gadget with a cord or battery power source.

Home Remodeling



Please consider donating, reusing or recycling the materials left over from your project. Fixtures, cabinets, flooring, and other items can often be used by others. If the material is not suitable for donation, it may be recyclable. Wood, tile and concrete, among other construction materials, are

usually accepted by local recyclers at a fraction of the cost imposed by the landfill or transfer station.
