

Time to Renew Your Property Owner ID Card

Continue to enjoy the many benefits the City of Indian Wells offers residents by obtaining or renewing your free annual Indian Wells Property Owner Identification Card.

For each residential dwelling in Indian Wells, a Property Owner ID card may be issued to the property owner, his/her spouse or domestic partner, and each dependent child (under the age of twenty-one years and unmarried) of the property owner and/or the spouse of the property owner.

Indian Wells property owners who have a photo on file at City Hall may request a renewal online at www. cityofindianwells.org (Click on IW Resident Information icon, Property Owner ID Card, Online Renewal Form.)

New Indian Wells property owners and first-time cardholders must apply for the Property Owner ID card in person at City Hall, Monday-Friday between the hours of 8 a.m. and 5 p.m. Please bring valid proof of property ownership such as a recorded grant deed or escrow closing statement. Current cardholders who wish to take a new photo for the 2013 card must also process their renewals in person at City Hall.

Valid Property Owner ID cards are required to gain entry to most resident events and to take advantage of resident discounts at the IW Club, Indian Wells Golf Resort, Indian Wells Tennis Garden, and four Indian Wells hotels.


Southers currently serves as the Associate Director for educational programs at the National Homeland Security


Tuesday, December 4: Residents' Night at WildLights



Harmful Insect Causes Suspension of Citrus Rescue Program for 2013

The Asian Citrus Psyllid has made its way to the Coachella Valley. This deadly citrus pest has the potential to destroy our local commercial citrus industry, as well as devastate backyard ornamental trees. The disease that this insect carries has already wiped out large portions of the citrus industry in Florida, Texas and Mexico.

Although there has been a quarantine in effect in our region for the past two years, Citrus Psyllids were recently discovered in Desert Hot Springs so local quarantine efforts have ramped up. In fact, the

State Department of Food and Agriculture is asking homeowners not to move citrus off of their properties.

With the stakes so high, Hidden Harvest has made the decision to suspend its Citrus Rescue program for the 2013 season and will continue to closely monitor the situation. Agriculture authorities, with the cooperation of homeowners and growers, are taking vigilant measures to eradicate this threat to Coachella Valley citrus trees.

A number of questions have been raised in the community regarding the Highway 111 project and I hope to address most of those questions in this overview. The Highway 111 project is a long-term, 50- to 75-year plan for the ultimate improvements envisioned on Highway 111 to meet the local and regional traffic safety and the congestion management plan. These long-term improvements include the widening of Highway 111 to six lanes: three in each direction, as well as left turn and right turn lanes with signals. The project has 12 phases involving Highway 111 and specific cross streets in Indian Wells. Most of the proposed improvements are designed to maintain highway safety and keep accidents and injuries to a minimum while some are aimed at relieving traffic congestion. The City of Indian Wells recently completed Phases 1 & 2. Our hope is that residents enjoy an easier commute on Highway 111 and are pleased with the new center medians that enhance the beauty, quality and image of Indian Wells.

The City sought funds from the Coachella Valley Association of Governments (CVAG), which oversees the distribution of many regional, state and federal funds to help pay for these improvements. The City received an Agreement from CVAG in which CVAG funding amounts to 75 percent of the Highway 111 project costs. (Note: The ultimate six-lane plan defined in the CVAG Agreement is projected in 2009 dollars to cost \$39.7 million.) This Agreement contains provisions to assure that once CVAG starts funding the early phases of the project, future project phases must also be completed or the City will be required to reimburse or return funding to CVAG. In other words, the City would have to repay all of the CVAG funding used up to the date the project is not in compliance with the Agreement if the City chooses not to proceed with subsequent Highway 111 project phases. Whether one agrees or disagrees

with the terms of the CVAG Agreement, it is an executed, binding contract, with which the City can be forced to comply.

The CVAG Agreement stipulates that when average daily traffic counts reach 60,000 trips per day, the City must proceed with Phase 4 of the project, which is the widening of Highway 111 to six lanes. The City's traffic engineers have estimated that if the past twenty years of traffic growth continued into the future, it would take approximately 35 to 40 years before the ultimate six lane improvements are needed. Due to the fact that the majority of the land utilizing Highway 111 for primary travel has been developed and it is projected to be some time before the desert begins to build high rise buildings, current traffic growth is highly unlikely to continue at this rate in the future. Moreover, a decrease in the current traffic growth rate would extend by many years the 35- to 40-year projection for 60,000 trips per day. One can argue that a six lane expansion may never be needed as transportation changes occur over the next 40 to 60 years. With rapid vehicle technology advancement and implementation, customized public transit systems, alternative transportation modes, and the escalation of costs related to vehicle ownership and operation, the existing four lanes on Highway 111 may be more than sufficient to safely accommodate future traffic beyond the foreseeable future.

The City is currently obligated to proceed with Phase 3 of the Highway 111 improvement project, which is essentially the Cook Street/Highway 111 intersection. However, implementation of Phase 3 has been cancelled for the upcoming high season. City staff will be meeting with Indian Wells merchants and homeowners to develop alternatives that significantly reduce impacts on businesses and residential areas. Any Highway 111 Phase 3 construction will occur only in the off season through summer.



Indian Wells Golf Resort: Annual Revenues and Debt

Indian Wells citizens and candidates have raised a number of questions regarding the Indian Wells Golf Resort's annual revenues and debt. I will refer you to my September 2012 newsletter article, *Indian Wells Golf Resort: The Operational Perspective*, also posted on the City of Indian Wells website at www.cityofindianwells. org (IW Resident Information, Announcements).

To summarize the two key points: First, the bonded indebtedness is not placed in the Indian Wells Golf Resort's budget because as a matter of law it must be posted in the Successor Agency fund. The revenues the City receives from Riverside County to pay the bond payments every year are also posted in the Successor Agency fund. Some have argued that the debt payments should be deducted from the Operations budget, which would show a huge loss. However, this would then ignore the revenues that the City receives to make these payments. The City operates the Golf Resort budget as close as possible within governmental rules like a private business, and like a private business you show all expenses and revenues. Thus, the net costs of the debt to the operation is zero by offsetting revenues from County property taxes.

Second, the revenue projections for the Indian Wells Golf Resort are developed by working with the Golf Resort's current operations management company, Troon Golf Inc., and Indian Wells' four hotels to assess the quantity of planned events and activities, and the hotels' estimates for occupancy. Based on the above, we can predict the number of golf rounds, as well as restaurant sales at the IW Club. This year, we had an unusually hot and humid summer, which reduced our normal summer play. However, in working with the hotels, we are projecting an increase in sales for a better-than-normal upcoming season, which should more than offset the summer decline.

The City has historically used redevelopment and general funds to offset some of capital and equipment expenses at the Indian Wells Golf Resort - this is no longer true. All the capital and equipment expenses are now identified in the Indian Wells Golf Resort operating and capital budget. The projected profit is net of these expenses and net of the debt service.

Troon's actual Gross Operating Profit (GOP) for 2012 was \$531,111. Troon's estimated GOP for 2012-13 fiscal year is \$617,801, a 16.3% increase. Again, this was developed working with Troon based on the amount of play that they are projecting, and was presented during budget hearing at City Council.
