
#### Resident Golf Tournament Slated for April 18





### Renaissance Esmeralda's Ali Brock Named 2010 Concierge of the Year



From December 26 through the second week of January, Burrtec Waste & Recycling collects Christmas Trees for recycling on your regular trash collection day.

Please remove all decorations and stands, cut trees into lengths not exceeding four feet, bind branches together, and place next to your trash and recycling carts.

Flocked trees must also be cut into four-foot lengths and placed next to trash containers but, unfortunately, cannot be recycled and are destined for the landfill.

## Safety Tips and Rules of the Road for Cyclists

With the winter season upon us, the number of motor vehicles and bicyclists on our highways and streets is rising. This high volume of traffic affects the traffic flow in and around the city of Indian Wells. The Indian Wells Police Department Traffic Bureau would like to remind residents who ride their bicycles of the following relevant California Vehicle Code Sections. This will help ensure your safety so you can enjoy the bicycling experience.



#### Laws applicable to bicycle use:

21200 (a) VC- Every person riding a bicycle upon a highway/roadway has all the rights and is subject to all provisions applicable to the driver of a vehicle in this division.

If you are operating a bicycle upon a roadway, the operator is subject to the same traffic laws as a driver operating a motor vehicle.



#### **Equipment Requirements:**

21201 (a) VC — No person shall operate on a bicycle on a roadway unless it is equipped with brakes.

21201 (d) VC — Bicycles must have a front lamp which is visible from a distance of 300', a red rear reflector which is visible from a distance of 500', white or yellow reflectors on both pedals, shoes or ankles which is visible from a distance of 200'.



#### Operation on roadway:

21202 (a) VC- Any person operating a bicycle upon a roadway at a speed less than the normal speed of traffic moving in the same direction at the time shall ride as close as practicable to the right-hand curb or edge of the roadway.



#### Permitted Movements from bicycle lanes:

21208 (a) VC- Whenever a bicycle lane has been established on a roadway, any person operating a bicycle upon the roadway at a speed less than the normal speed of traffic moving in the same direction at that time shall ride within the bicycle lane.

21453 (a) VC- A driver facing a steady circular red signal shall stop at a marked limit line, but if none, then before the crosswalk on the side near the intersection.

22450 (a) VC- The driver of any vehicle approaching a stop sign at the entrance to, or within, an intersection shall stop at a limit line. This is often a misconception amongst bicycle riders that "slowing down" before proceeding through the stop sign is sufficient. The law requires you to make a complete stop, same as a motor vehicle.

These are just a few vehicle codes that apply to bicyclists. For more information regarding bicycle safety please do not hesitate to notify your local traffic services officer.


