

#### CITY DEVELOPMENT PROJECTS UPDATE



#### Highway 111 Beautification/Widening

The Highway 111 Beautification and Widening Project, set to begin spring of 2009, is designed to improve traffic flow and reduce traffic congestion. It will also enhance the entire aesthetic experience of Indian Wells, further solidifying our city's position as one of the nation's top residential resort communities.

The Highway 111 project will also demonstrate the city's commitment to promoting a sustainable, or "green," environment: The project encompasses adding medians throughout the city's Highway 111 corridor embellished with palm trees, synthetic grass and drought-tolerant plants. An additional lane will be added in each direction to reduce congestion and improve air quality.

Slated for completion in early winter of 2010, the first phase of construction will include sound walls, medians, landscaping and widening between Hospitality Lane and Rancho Palmeras Drive. Second phase construction will begin summer of 2010 between Rancho Palmeras Drive and Club Drive. The final phase from Club Drive to the city's eastern boundary will begin in summer of 2011 and is slated for completion in 2012.

#### Indian Wells Towne Center

Indian Wells City Council approved an open-air "paseo-style" lifestyle commercial center located at the intersection of Miles Avenue and Washington Street. The center will consist of up to 400,000 square feet of space for high-end retail stores, offices, and restaurants including Morton's of Chicago steakhouse. Residents and guests will also be able to experience a 13-screen multiplex theatre owned and operated by Krikorian Premiere Theatres. Indian Wells Towne Center's interconnectivity with the Indian Wells Tennis Garden presents a unique opportunity for visitors who frequent the Garden to take advantage of "will call" ticketing, dining, shopping, and movies.

The developer anticipates starting Phase I grading in April 2009 with completion by winter 2011; Phase II will follow. Leasing opportunities are available via Maggie Montez at CB Richard Ellis, (760) 341-2272.





### Indian Wells Crossing (formerly called Miles Crossing)

Indian Wells Crossing will be located at the intersection of Miles Avenue and Highway 111. This fantastic lifestyle commercial center will consist of up to five or six upscale restaurants including The Chop House, a French bistro, sports bar, and wine café — all to be completed in Phase I. There will also be related resort retail stores and offices.

Indian Wells Crossing will offer opportunities for street fairs and community events surrounded by open air dining.

Phase I construction to encompass approximately 117,000 square feet is scheduled to begin in April 2009 and slated for completion by summer 2010. Phase II will be under review in upcoming months. 





### GO GREEN:

### Heating and Cooling Energy Saving Recommendations



When you live in a desert climate like ours — hot summer days and cold winter nights — you should consider replacing your older central air conditioner or heating system with an ENERGY STAR qualified unit. A central A/C unit is designed to last 12-15 years, so the older your equipment, the more likely it is inefficient and unreliable. Your A/C quality contractor can help you decide whether it's time to replace your old model with premium efficiency equipment. Newer energy efficient models can reduce your utility costs, save energy, and reduce greenhouse gas emissions. Look for ENERGY STAR equipment with a Seasonal Energy Efficiency Ratio, or SEER, of 14 or higher as these models offer higher energy savings. In fact, if all California households with old, inefficient (SEER 11 or lower) central air conditioners upgraded to ENERGY STAR qualified models, it would be the energy saving equivalent of taking 278,000 cars off the road.

Have your new energy efficient systems installed by a licensed heating and cooling contractor, and be sure to have a professional return annually to service the units.

After ensuring you have energy efficient equipment, there are additional ways you can reduce your energy footprint at little or no cost:

- When cooling your home, increase your thermostat by 3-5 degrees when you are home; set it to 85 degrees or higher or turn your A/C off when you leave.
- When heating your home, reduce your thermostat by 3-5 degrees when you are home; set it to 55 degrees or lower or turn off your heater when you leave. Lowering the temperature 3-5 degrees can save you up to 20% on heating costs.
- Regularly inspect, clean or change the air filters in your central air conditioners, furnace and/or heat pump. Dirty filters limit air flow and increase energy use.
- Ensure that any air leaks are properly sealed and your home has the proper insulation to increase your home's comfort and reduce your heating and cooling bills.

The City of Indian Wells is committed to leading the way in energy savings and affordability. City homeowners are still eligible to receive monetary incentives for energy efficient appliances through December 31, 2008 through the city's IW HEAL Conservation Incentive Program. ### Christmas Tree Safety Tips

Christmas trees are beautiful and a much-loved tradition during the holiday season, but they can be a fire hazard if not carefully decorated and maintained. Be sure to follow these important recommendations to make your holidays safer:

- Make sure you place your tree in a sturdy tree stand at least three feet away from any heat sources, such as a fireplace, and do not place it where it may block exits.
- Give your tree plenty of water daily to keep it moist.
- Always use lights listed by a testing laboratory when decorating your tree.
- Do not use any string of lights with worn, frayed or broken cords, or loose bulb connections.
- Always unplug Christmas tree lights before leaving home or going to bed.
- Never use lit candles to decorate a tree, and make sure any lit candles in the room are
  placed well away from tree branches.
- If you purchase an artificial tree, be sure it is labeled as fire-retardant.
- Keep a watchful eye on children and do not let them play with tree wiring or lights.
- Safely dispose of the tree when it begins dropping needles; dried out trees are highly flammable.
