


Look Who's Talking in 2008 DESERT TOWN HALL— INDIAN WELLS



Results in Crime Prevention

The prevention of crime is very important to all of us. Any infiltration of crime into our community affects our sense of safety and impacts overall quality of life. As a result, modern law enforcement agencies are taking a new approach to combating crime known as **Community Oriented Policing**. In simple terms, this philosophy of crime prevention involves

cooperative efforts between law enforcement agencies and the citizens they serve.

Community Oriented
Policing differs from
traditional law enforcement
in that traditional methods
lacked true community
involvement and involved
reacting to problems as

they occurred. The result was that this type of enforcement primarily dealt with the immediate problem but provided little, if any, resolution to long-term issues.

Community Oriented Policing is the future of law enforcement. Law enforcement officers will not only continue efforts to resolve immediate problems, they will also be looking at ways to eliminate future problems. Officers trained in this type of policing will analyze data, identify problem areas, develop a plan of action, and implement that action plan.

The citizen's role in this concept requires active participation. Law enforcement needs citizens to become involved by taking active roles in reporting crime and adopting measures to protect themselves. Law enforcement agencies are well aware that not all citizens understand the basics of crime prevention and that the role of public education rests in the hands of law enforcement. By educating citizens and gaining their participation, we all can create and maintain a safer community.



In Indian Wells, property-related crime is the most significant problem. Below are a few key crime prevention tips to assist residents in protecting their property:

Secure your belongings



We no longer live in an environment where we can safely leave our doors unlocked or our property unsecured. Keep your doors locked at <u>ALL</u> times. This same concept applies to your vehicle. Keep it locked and, if possible, parked in your garage, and make use of all alarm systems.

• Remove the opportunity to be victimized



Criminals are opportunists. They will take advantage of any opportunity presented to them to steal your belongings. Don't leave anything of value in your vehicles or in public view. If they can't see the property, they will most likely leave the area.

• Report suspicious activity



Be suspicious. If something or someone looks out of place, call law enforcement. Don't rationalize what you are seeing; take a moment to report it when it is occurring. Don't wait.


• Be a good neighbor





City of Indian Wells Enjoys

"The City of Indian Wells just closed the books on its strongest financial year in history. This year, the city's General Fund posted an \$8.3 million net operating surplus with \$37.7 million in reserves," says City Manager Greg Johnson. Positive economic indicators, tourism demand, capital investments back into our economy, valley growth, and short term interest rates are all indicators of continued strong revenue performance.

"By looking at the Statement of Net Assets and the Statement of Activities we know how the city performed throughout the year,' adds Johnson. "These statements demonstrate financial activity of the city as a whole." The City of Indian Wells remains in outstanding financial condition with strong revenue growth and prudently managed operational expenditures. A fundamental goal of the city is to continue to efficiently monitor and improve the public services it delivers. City Council remains focused on using resources prudently and effectively to improve the already high quality of life that represents Indian Wells.

As a No/Low property tax city, Indian Wells collects very little property tax from the County of Riverside—only 7% of the 1% of property assessed valuation. As a result, the City of Indian Wells, a world-class luxury resort destination, has had to rely on revenues generated from tourism to support its public services. Today, over 50% of the revenues generated in the city's General Fund are tourism—based. Vital to the city's tax base are three key economic components: resort hotel properties, restaurants and golf.

Golf is the primary recreational activity supporting the resort hotels and related retail shops in Indian Wells. The city-owned Indian Wells Golf

Resort with its spectacular mountain views and stunning park-like setting is designed to augment the existing amenities of the four surrounding luxury resort hotels, and maximize the resorts' ability to generate transient occupancy tax revenues for the city.

During the last ten years, the City of Indian Wells has been in a growth phase with net assessed values increasing from \$2.0 billion in fiscal year 1997/98 to \$4.3 billion in fiscal

year 2006/07. This major increase in assessed value consists primarily of residential development. During the same period of time, the city's net assets have grown from \$87.1 million to \$156.6 million further emphasizing the economic success occurring in Indian Wells.

During fiscal year 2006/07, the city's net assets increased \$15.0 million over the previous year to reach \$156.6 million. Citywide revenues

climbed \$4.0 million over last year to reach \$68.8 million. Collection of property tax and transient occupancy tax remain at historic highs. Indian Wells is seen by homebuilders and homebuyers alike as an exceptional place to build and live. The booming housing market has resulted in greater than budgeted development fees and charges for services. As a result of the increased population, Indian Wells is experiencing retail growth that has

added sales tax revenue to the city. City expenditures decreased \$3.4 million over last year declining to \$54.2 million through prudent fiscal management.

"The real story and excitement for our residents in the coming months is the nearly completed Indian Wells Golf Resort," says Johnson.
