For the second year in a row, the Pacific Life Open's attendance topped 300,000, with the final total of 331,269. Attendance has grown ten fold since the inaugural tournament in 1976 when 30,000 spectators were present. The all-time day (21,512) and night (16,386) session attendance records were set on Saturday, March 15, 2008, making this event the most attended tournament in the world outside of the four Grand Slams.



2008 "Rediscover the Art Museum" Lecture Series Wraps Up with a Look at the Desert's Modern Architectural Gems





On April 1, a full house of Indian Wells residents gathered at the Indian Wells Country Club for the final 2008 installment of "Rediscover the Art Museum." a resident-only art lecture series sponsored by the City of Indian Wells and Palm Springs Art Museum.

Museum Associate Curator Sidney Williams guided residents through a delightful and insightful look into the desert's unique mid-century modern architecture and its creators. Many of the era's premier designers were influenced by Frank Lloyd Wright and came to California because it was a place known for "innovative thinking." Top architects of the modern style – many of whose works are preserved in the Valley today – include Albert Frey, E. Stewart Williams, William Cody, Richard Neutra, A. Quincy Jones, William Krisel, John Lautner, and Val Powelson who designed the original Indian Wells Country Club.

Part of the modernistic aesthetic, Williams explained, is not only the integrity of materials used, but also the architects' desire to integrate interiors and exteriors, taking advantage of the ephemeral desert light and spectacular scenery.







And the 2008 Senior Inspiration Award Goes to...Adele Ruxton!

On April 11, 2008, 11 Coachella Valley residents over the age of 70 received Senior Inspiration Awards paying tribute to their contributions to the desert community. One of those honorees was Indian Wells' very own Adele Ruxton.

Ruxton has been involved in numerous volunteer activities during her 45 years living in the Coachella Valley. And giving back to her community has been a major part of Ruxton's life since her early childhood in Torrance, California. She recalls that "it was very rarely that I ever heard my mother say 'no' when asked, 'would you have a little time?'"

In 1996, Ruxton co-founded the Student Creative Recycle Art Program (S.C.R.A.P.). She also serves on the board of the Indian Wells Historic Preservation Foundation and has served on the board of the Children's Discovery Museum. Additionally, Ruxton is an active member of the Indian Wells Chamber of Commerce, American Association of University Women, Conference of California Historical Societies, and La Quinta Arts Foundation. She is also a member and scholarship chair of the California Retired Teachers Association, Roadrunner Div. #43.

After receiving a Bachelor of Arts degree in early childhood education from UC Santa Barbara, Ruxton taught second grade in Santa Clara, California. She also spent a number of years in Thailand at the International School of Bangkok.



Arriving in the Coachella Valley in 1963, Ruxton worked as a kindergarten-primary school teacher at Oasis and Mecca Elementary School in the Coachella Valley Unified School District. She also worked for College of the Desert teaching English to Spanish-speaking farm laborers. During her teaching career, she was involved in many volunteer initiatives, including an informal after school program at Mecca Elementary and serving as director of a migrant education program. Ruxton resides in Indian Wells with her husband, Edward. Please join us in congratulating her on this marvelous honor!

Residents Donate Reusable Materials during Every construction project nerates a wide variety of debris; Home Renovation

Every construction project generates a wide variety of debris; however, salvaging construction and demolition materials for reuse can reap many rewards. These include conserving natural resources, limiting what goes into our landfills, reducing disposal costs, and — like one Indian Wells couple discovered — helping others in need.

The Nason family bought a home in Indian Wells in July of 2007 with the goal of totally transforming it into their ideal weekend and retirement home. Prior to renovating, they consulted with Indian Wells Recycling Coordinator Kenn Stevens to prepare a required Debris Plan

that would incorporate the city's goal of 50–70% recycling of wastes from construction and demolition sites.

The Nasons wished to donate several interior materials for reuse, but did not receive any responses from the organizations that they contacted. Enter an attendant for an elderly neighbor with an idea: she suggested they donate the 1600-square-feet of good carpeting that they were replacing to a family in Mexicali who had recently lost their home in a fire.

The project's demolition technician also had suggestions on where to send other salvageable materials. Subsequently, the Nasons donated 17 windows and sliders to a church in Mexico. They have also donated toilets, sinks, and cabinetry, and will be donating a furnace and pool equipment. Additionally, they are reusing river rock in their new desert landscaping, and hope to complete the entire project sometime this summer.

About salvaging and contributing the items from their home renovation, Michael Nason says: "It was gratifying. I watched them load the material and it was nice to see that it wasn't thrown into a dumpster, but rather carefully packed into a truck. It was precious cargo."



Jane Bryant Quinn Shares Investment Tips at Desert Town Hall—Indian Wells

As she began her March 18 Desert Town Hall lecture, and in reference to the nation's dismal economic climate, Jane Bryant Quinn noted that the timing couldn't have been more perfect "to have a financial speaker."

The nation's leading commentator on finance covered a range of topics during her speech before capping it off with investment advice and a Q&A session with the audience. Below are a few highlights from her lecture:

The overall state of the economy: "Today everything is not okay and we need to be realists. Our financial system is not broken but it is definitely cracked."

On recession: "I think we are probably in one, although it hasn't been called that yet. The May tax rebates will help mitigate the damage."

On the dollar and foreign investors: "One good thing about the cheap dollar is that the U.S. is encouraging exports and the world is coming to invest here now — we are 'the bargain basement'...I am personally not worried when I see foreign capital taking an interest; I am relieved...foreign investors are saving jobs and communities."


On regulation of banks and investment institutions: "Regulation is coming back into the picture, but we don't know where or how yet."

On housing: "Over the next 30 years, we will see home prices flattening out; it will not be the top investment on your mind."

On oil: "The entire developing world is barreling into a liquid fuel crisis... and we are woefully unprepared for this."

Personal investment guidance:

- The simplest financial products work the best. There are always risks in investing, but they need to be "measured" risks.
- Bryant Quinn recommends buying indexed, no-load mutual funds in lieu of individual stocks.
- A well-diversified portfolio that is regularly rebalanced is key to economic success and stability.

TEN SUMMER ENERGY SAVING TIPS

When summer comes to the desert, increased utility bills often follow. But, there are ways to reduce your energy costs during the hot weather months, which have the additional benefit of minimizing the strain on our precious natural resources. Here are a few things you can do to take control of your energy use:

- 1. To save money on your summer electric bills, consider enrolling in Southern California's Residential Summer Discount Plan. For details, call 1 (800) 497-2813 to speak to a SCE representative or visit www.sce.com/sdp.
- 2. Replace standard incandescent light bulbs with compact fluorescent light bulbs and save 75% of lighting costs.
- 3. To save energy when your A/C is on, increase your thermostat setting by 3-5 degrees. Leave your A/C at 85 degrees or higher, or off, when you're away from home. Also reduce A/C costs by using fans, keeping windows and doors shut, and closing shades during the day. For additional insulation, try "thermal-backed" curtains. Up to 25% of a home's energy loss occurs through its windows.
- 4. Turn your water heater down to 120 degrees or to the "Normal" setting when home, and to the lowest setting when away. Water heating accounts for about 12% of home energy costs.
- 5. Unplug electronics, battery charges, and other equipment when not in use.

 Taken together, these small items can use as much power as your refrigerator.
- 6. Wash clothes in cold water. About 90% of the energy use in a clothes washer goes to water heating. Also, do laundry between 7 p.m. and 7 a.m. when lower electricity rates are in effect.
- 7. Enable "power management" on all computers and make sure to turn them off at night. A laptop computer uses up to 90% less energy than bigger desktop models.
- 8. Install timers or photocells with motion sensors to ensure outside security lighting is used only when needed.
- 9. Fill up your dishwasher completely, run the load, and then let dishes air dry. Your dishwasher uses less water than washing dishes by hand.
- 10. Unplug or recycle that spare refrigerator/freezer in the garage if you don't need it. Also, a freezer operates most efficiently when full. Consider filling empty space with water-filled plastic jugs. Lastly, if you can, replace older appliances with Energy Star® models. 
Hyatt Grand Champions Draws a Crowd to Season Social #3


