




Sensational IW Club IS YOURS TO ENJOY!







GO GREEN: Why Should I Replace My Pool Pump Now?

Did you know that your pool pump may be costing you hundreds of dollars in unnecessary energy costs each year? This is because most traditional pumps are single speed models with large induction style motors.

You can save energy and lower your electric bill when you replace an older, standard pool pump with a smaller, high efficiency model. Featuring magnet motor technology and custom programming options, new digitally controlled, variable speed pumps ensure cost and energy savings. When you replace your pool pump, be sure to use the smallest size possible pump for your pool to save on pumping and maintenance costs. A study conducted by the Center for Energy Conservation in Florida determined that a 0.75 horsepower or smaller pump is generally sufficient for residential pools.

Other energy saving recommendations include:

- Reducing filtration time for six hours per day. If the water doesn't appear clean, increase the time in half-hour increments until it does.
- Installing a timer to control the pump's cycling. Several short cycles keep the pool cleaner all day.
- Keeping the intake grates clear of debris. Clogged drains require the pump to work harder, which uses more energy.

Additional tips include shutting down unnecessary fountains and waterfalls to reduce pumping costs, and using covers on pools and spas. You can even take advantage of our sunny climate and buy a specially-designed solar cover to heat your pool.

Although there is presently not an ENERGY STAR® pool pump on the market, new developments are on the horizon. You can purchase a high efficiency model via Pentair Water Pool and Spa. For more details, visit their website at www.pentairpool.com.

Prepare for the Flu Season Today

As flu season begins, it is important to be protected against this contagious respiratory disease. Anyone who wants to reduce the chances of getting the flu should be vaccinated; however, the vaccination is highly recommended for those at high risk for complications from the flu and those who live with or care for individuals at risk. These include:

- Children, 6 to 59 months old
- Pregnant women
- Adults, 65 years of age or older
- People with certain chronic medical conditions
- Residents of nursing homes and long-term care facilities
- Health care workers who have patient contact
- Caregivers and household contacts of high risk persons

Contrary to popular myth, all the influenza viruses in a flu shot are inactive, so it is not possible to get the flu from the vaccine. Protection develops approximately two weeks after receiving the shot and may last up to one year.

Eisenhower Express Clinic and Primary Care in Indian Wells is offering the flu vaccine Monday through Friday from 8:30 a.m. to 4:30 p.m. Cost of the flu shot is \$35; the Express Clinic can bill Medicare for appropriate individuals. The Clinic is located at 74785 Highway 111, Suite 100 in Indian Wells (in the rear of the Wall Street West complex).

On September 1, 2008, California enacted a state law making it illegal to dispose of syringes in trash or recycling containers. Hypodermic and intravenous needles, lancets, and pen needles can carry disease, spread germs, damage recycling equipment, and injure sanitary workers and others. These household "sharps" must be properly discarded via an approved recycling container or collection center.

To help further this public health initiative, Eisenhower Express Clinic and Primary Care in Indian Wells now serves as a sharps collection site. Indian Wells residents can drop off sharps in containers, as well as unfinished prescription drugs which are also a health and environmental hazard if improperly disposed. Please remove all labels from prescription drugs prior to drop off.

Used or unwanted household sharps can also be dropped off at the city's monthly Household Hazardous Waste Disposal events.

Turn Your Clock Back and Check Your Smoke Detector

The return to Standard Time on Sunday, November 2, is also the ideal time to replace those batteries in your smoke detectors. If you do not have smoke detectors near the kitchen and every sleeping area of your home, now is also the time to install them.

Smoke rises, so be sure to mount the alarms high on walls or ceilings. Ceiling mounted alarms should be installed at least four inches away from the nearest wall; wall-mounted alarms should be installed four to 12 inches away from the ceiling. If you have pitched ceilings, install the alarms near the ceiling's highest points. Also keep alarms away from any area where drafts might interfere with their operations.

Hard-wired smoke alarms operate on your household electrical current. They can be interconnected so that every alarm sounds regardless of the fire's location. Alarms that are hard-wired should have battery backups in case of a power outage, and should be installed by a qualified electrician.

To keep your smoke alarms working properly test them monthly and don't disable them even temporarily. If you are remodeling or building a new home, consider installing an automatic home fire sprinkler system. Sprinklers and smoke alarms together save thousands of lives every year.
