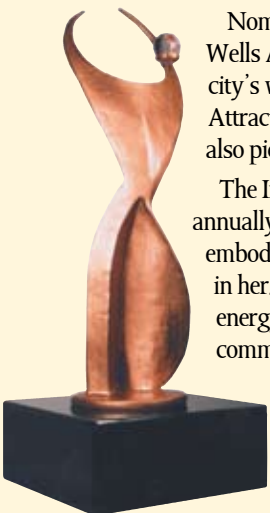

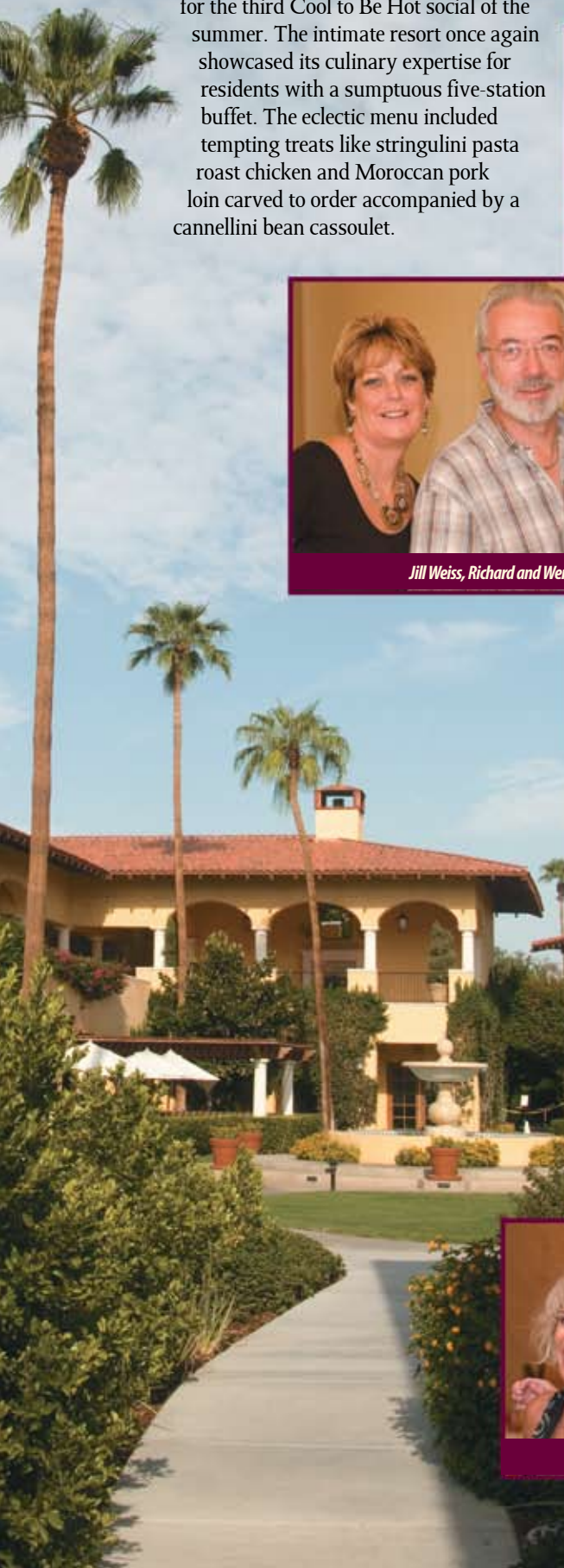

# 2008 GENERAL ELECTION: VOTE!

Make sure that you are registered to vote in the Consolidated General Election on Tuesday, November 4, 2008. In order to be able to vote in the November 4 election, your registration must be postmarked no later than October 20, 2008. You should re-register to vote if you have moved, changed your name, or changed your political party choice.

Your polling place location will be printed on the sample ballot you receive prior to the election from the Riverside County Registrar of Voters. All polling place locations are open on Election Day from 7 a.m. until 8 p.m.

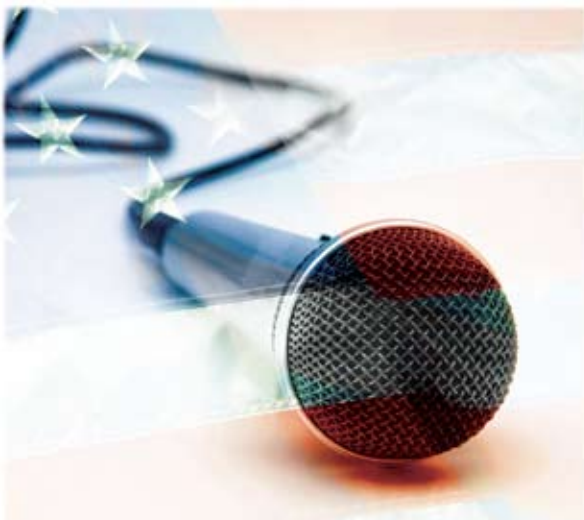

Your windows may provide wonderful views of our lovely desert scenery; unfortunately, they may also add higher costs to your energy bill year-round. If your home currently has single-pane windows, consider replacing them with ENERGY-STAR qualified windows that can help reduce your heating and cooling costs by up to 15%. ENERGY-STAR qualified windows, doors and skylights offer advanced technologies including multiple panes, special reflective coatings, and improved framing materials that can help you save energy, cut costs, and maximize comfort. Choose a qualified installer to ensure proper installation and avoid air leaks around frames.

If replacing your windows, doors and skylights is beyond your budget right now, here are some tips that can help you improve their performance:

- Add weather stripping around windows, doors and skylights to reduce drafts.
- If your windows still feel drafty after weatherizing, install tight-fitting, insulating window shades.
- Apply sun-control or other reflective window films on south-facing windows to reduce solar gain.
- Close curtains on east-, south- and west-facing windows during the day on hot days.
- Install shade covers, sunscreens and blinds to reduce heat.
- Install white window shades, drapes or blinds to reflect heat away from the house.
- On cold days, close your windows and shades at night, and open them during the day.

# Set to Enter the Digital Age?



On February 17, 2009 the nation's full power television stations will fully switch over from analog to digital broadcasting. If you currently view programming via an antenna (set-top or roof-top), without a cable or satellite system, you will need to either:

- 1) purchase a digital-to-analog converter box to plug into your television;
- 2) subscribe to a cable, satellite or telecommunications service provider if your local broadcast stations are aired by that service; or
- 3) purchase a new television set with a built-in digital tuner.

## Candle Safety

Many people enjoy burning candles in their homes; however, according to the National Fire Protection Agency, the number of house fires caused by candle use has increased by 15% over the last three years. The National Fire Incident Reporting System relates that nearly 85% of candle fire incidents start due to product misuse. Reduce the chance of a fire starting in your home by using the following simple candle safety tips:

- Never leave a burning candle unattended
- Never place a burning candle near something that can catch fire
- Keep burning candle out of the reach of children and pets
- Keep candles away from drafts and vents
- Trim wicks to ¼" prior to each use
- Normally don't burn candles more than four hours at a time
- Extinguish taper or pillar candles when they get within 2" of their holders
- Always use containers that have been made for candle usage
- Discontinue use of a container candle with ½" of wax remains
- Keep matches, wick trimmings, and foreign objects out of the candle wax
