City Treasurer's Report for May 2021

RECOMMENDED ACTION:

Council **RECEIVES** and **FILES** the City Treasurer's Report for May 2021.

DISCUSSION:

Attached are the monthly cash balance and investment reports for the month of May 2021. The investments reflected in this report are "Marked-to-Market", meaning the market value of City's investments is updated monthly. This method provides a clear depiction of the value of the City's portfolio subject to the performance of the investment market. The City of Indian Wells continues to maintain prudent fiscal reserves and minimize un-invested cash.

Cash and Investments

As of May31, 2021:

- The City's cash and investments totaled \$75,817,536.39.
- The City's portfolio earned a 1.229% rate of return.

Treasurer's Certification

Compliance - The City's investment policy limits the purchase amounts of Aaa rated Federal Agency Securities to 70% of the portfolio and \$15,000,000 per issuer. Federal Agency Securities like Federal Home Loan Bank (FHLB), Fannie Mae (FNMA), and Freddie Mac (FHLMC) are the preferred investment of the City due to Federal credit quality. Due to the extreme lack of issuance from FNMA and FHLMC, during the month of May 2021, the City temporally exceeded the purchase limit of FHLB by \$2,000,000.

Approximately 90% of all Federal Agency Securities issuance available in the marketplace in 2021 have been exclusively from FHLB. It is expected the City will meet the \$15,000,000 investment policy limit by June 30, 2021. Since most California municipalities do not impose a per issuer limit on Federal Agency Securities and there is no limit in the State Investment Code, the City may revisit this guideline limit in the next Investment Policy adoption.

Liquidity - The City Treasurer certifies the City's portfolio is sufficient to meet its financial obligations for the next six months. The investment portfolio will remain sufficiently liquid to meet all

operating requirements, which might be reasonably anticipated. This is accomplished by striving to have securities mature at the same time cash is needed to meet anticipated demands (static liquidity). Additionally, since all possible cash demands cannot be anticipated, the portfolio consists largely of securities with active secondary or resale markets (dynamic liquidity).

Fiscal Prudence

When investing, reinvesting, purchasing, acquiring, exchanging, selling, or managing public funds, a trustee shall act with care, skill, prudence, and diligence under the circumstances then prevailing, including, but not limited to, the general economic conditions and the anticipated needs of the City, that a prudent person acting in a like capacity and familiarity with those matters would use in the conduct of funds of a like character and with like aims, to safeguard the principal and maintain the liquidity needs of the City.

Background

Staff provides Council with a monthly update to the Treasurer's Report. The Report presents the City's cash activity and investment portfolio and provides reconciliation between investment balances and the General Ledger. Specifically, the report provides information on the types of investments, dates of maturities, costs, updated market value of securities, and rates of interest earned in the portfolio.

The City maintains a written investment policy in compliance with legal requirements of Government Code section 53600 and governs the investments made by the City. It is the policy of the City of Indian Wells to invest public funds in a manner that will provide the maximum security with the highest investment return while meeting the daily cash flow demands of the City. The investments purchased by the City are consistent with the City's investment policy and are allowable under current legislation of the State of California.

The City invests in U.S. treasuries, federal agency securities, medium term corporate notes, municipal bonds, federally insured certificates of deposit, and overnight cash investments. Criteria for selecting investments in order of priority are: (1) safety, (2) liquidity and (3) yield.




