### **PROJECT OVERVIEW**

The Eldorado Tree Replacement Plan stems from the storm damage incurred on August 20, 2023. The City of Indian Wells incurred catastrophic damage of most street trees along Eldorado Drive. As a result, the City's Maintenance Division Team <u>removed</u> 61 Trees.

Phase 1 (Current Project): Includes replacement of 40 Trees

Phase 2 (Future Project): Includes replacement of 21 Trees












