Deputy Ford arrived and arrested Christopher Rydman, age 36 of Indian Wells, for being under the influence of a controlled substance. He was booked at JBDC.

The investigation determined Zepeda was calling from a mental institution in Tucson, Arizona and the threat was not credible. Personnel at the mental facility were notified and will be conducting another mental health evaluation.
